- We were not able to find a time and date from the metadata of the wechat message screengrabs. If the messages began circulating around Sep 8 or 9, the date when the first op-eds about Chiu and C-282 appeared, it might give us some more clues about what level of coordination.
- Did the person who took the screengrabs receive these messages in a group message chat? We assume this is case, based on the appearance of the interface in the screengrab, but it would be good to confirm. If possible, it would be great if we could learn more about what kind of group chat this is (a group chat started by a WeChat news account, or a personal one for family/friends, etc.).
