REPLY TO YUKON PREMIER RANJ PILLAI REGARDING CANADA'S RELATIONSHIP WITH INDIA AND SHARING SECURE INTELLIGENCE WITH PREMIERS

SUMMARY

- The Premier of Yukon, Ranj Pillai, wrote to you on October 31 (**Tab C**), in his capacity as Chair of the Western Premiers' Conference. The letter expresses concern at a lack of consultation with premiers regarding national security incidents, the inability of security agencies to share classified information with provincial and territorial officials and notes support for the normalization of relations between Canada and India.
- The proposed response (Tab A) addresses Premier Pillai's request for intelligence sharing and discusses Canada's ongoing diplomatic engagement with the government of India.
- Transmittal letters for Ministers LeBlanc, Blair, Joly, Ng, as well as other western premiers are attached for your signature (Tab B).

Background

- Although foreign policy is an area of federal jurisdiction, premiers have increasingly asked to be consulted in security matters affecting their respective provinces and territories (PTs). Premier Pillai and British Columbia Premier David Eby have been particularly vocal and have criticized the inability of the Canadian Security Intelligence Service (CSIS) to share classified and actionable information with provincial and territorial officials due to restrictions imposed by the CSIS Act. The letter requests changes to the CSIS Act and other federal policies to facilitate the sharing of classified information with PTs.

In addition, officials from Public Safety and Justice Canada notified federal, provincial, and territorial assistant deputy ministers of intergovernmental affairs at a meeting on November 8 that bilateral engagements with PTs would be carried out over the coming months on the proposed legislative amendments.

- PTs have paid increasing attention to export promotion, including in India. Premier Pillai's letter makes note of India's increasing significance as a market for Western Canadian exports and a major source country for skilled immigrants. Provincial trade envoys from Alberta, British Columbia and Saskatchewan were among those forced to leave India in recent weeks. Accordingly, Premier Pillai's letter expresses hope that "current challenges in the federal government's relationship with India are expeditiously resolved".
- PCO recommends highlighting the deep, long-standing ties between Canada and India, Global Affairs Canada's (GAC) continued engagement with the government of India and the fact that Canada is not seeking to escalate tensions. This language aligns with GAC's public messaging.

Dear Premier:

Thank you for your letter of October 31, 2023, regarding Canada's relationship with India and the sharing of secure intelligence.

I appreciate your concern regarding the sharing of classified information. Our government recognizes the need to ensure our security practices evolve with the nature of the threat posed by foreign interference. We are always looking at ways to strengthen the national security mechanisms currently in place, legislative or otherwise, and we look forwarding to working with other orders of government on improving information-sharing. This is why Minister LeBlanc and Janice Charette, then-Clerk of the Privy Council, committed in an April 2023 report to expanding briefing mechanisms with provincial and territorial officials and increasing awareness of foreign interference threats. Public Safety Canada is planning to launch National Security Consultations on proposed amendments to the CSIS Act, with a view to modernizing the Act to improve intelligence sharing. We look forward to hearing your views through this engagement.

The Department of National Defence is committed to continuing to enhance communication and mutual understanding with provincial and territorial governments. Among other measures, biannual threat briefings for territorial Premiers help facilitate the transmittal of information, support your decision-making and provide regular touchpoints. The next threat brief with territorial premiers will take place after the election in the Northwest Territories.

As you know, the international environment is becoming increasingly complex and the rules-based international order has come under strain. Canada has continued to work with like-minded partners to advance our interests and values and address shared global challenges.

The Indo-Pacific region is an integral part of this approach. In November 2022, Minister Joly released Canada's Indo-Pacific Strategy to guide our engagement in the region. The federal government is committed to developing strong relationships with partners across the Indo-Pacific. This year, Minister Ng has led Team Canada Trade Missions to Japan and Singapore, with missions to Indonesia, the Republic of Korea, Malaysia, the Philippines, and Vietnam planned in 2024. We welcome the involvement of provinces and territories in these Team Canada Trade Missions, and in all of Canada's relationships with Indo-Pacific partners.

The federal government shares your concerns about the alleged link between agents of the Indian government and the killing of Hardeep Singh Nijjar. The federal government will continue to support the investigation of this incident. We have been in regular contact with the Indian government and hope they will cooperate.

Canada's intention is neither to provoke, nor to escalate. Canada and India have a long history of close relations, with unique economic and people-to-people ties. Accordingly, we have been acting in a measured and responsible way, in accordance with our values and with international law. Canadian companies are continuing to conduct business in India, with support from our trade network in Canada and in India. We welcome the Indian government's decision to resume issuing visas, including business visas, to Canadians, albeit in limited numbers, and we continue to welcome newcomers from India and elsewhere, whether they wish to come here to visit, work, study, reunite with loved ones or call Canada home. The federal government will continue to keep provincial and territorial governments apprised of developments as they occur.

Dear Prime Minister Trudeau.

RE: Ensuring the future success of the Canada-India relationship and sharing secure intelligence with Premiers

Western Premiers have been deeply troubled by increasing reports of foreign interference in Canada. In particular, we are concerned about the alleged link between Indian government agents and the murder of Hardeep Singh Nijjar. We support efforts by Canada's law enforcement agencies to ensure those responsible are held accountable. However, as Chair of the Western Premiers' Conference, I wish to raise our concern that the federal government has not sufficiently engaged western jurisdictions regarding Canada-India relations during these challenging times.

Principally, there are issues in sharing information and intelligence with Premiers. We have not been provided timely access to relevant information on foreign interference and national security to support decision-making. Despite gaining limited security clearances, executive branches and senior officials in provincial and territorial governments are supplied with only unclassified briefings, not the necessary classified briefings to manage strategic engagements with international governments.

To address this situation, we request that you immediately review the legislative, regulatory, and policy frameworks in place, including the Canadian Security Intelligence Service Act (CSIS Act), to reduce barriers to intelligence-sharing and ensure timely and quality information is provided to provinces and territories. This should also include due attention to necessary physical and digital security infrastructure that enables access to sensitive information for provincial and territorial officials.

Western provinces and territories have longstanding and important interests in India. During these challenging times, our governments must continue to engage at all levels of the Indian government

and society to achieve our economic and social goals. As part of developing provincial and territorial markets and workforces, Western Premiers will continue to seek skilled workers, build foreign markets for Canadian goods, and attract investment to our jurisdictions. It is our hope that the current challenges in the federal government's relationship with India are expeditiously resolved, those responsible for the murder of Hardeep Singh Nijjar are held accountable, and that a normalization of relations between India and Canada will soon follow.
