




Rapport de repérage des médias sociaux : midi 4 octobre à midi 6 octobre, 2019 Social Media Monitoring Report: noon October 4 to noon October 6, 2019

Observations principales / Key observations

- Users reacted to a CTV news article about non-citizens on the NROE (8K shares, and an equivalent French article published by TVA with 2K shares); many are "concerned" or "disgusted" that EC does not require proof of citizenship at the polls
- Following news of convicted murderer Luka Rocco Magnotta receiving a VIC, users criticized VIC
 accuracy, with one Senator writing "this travesty illustrates exactly why Elections Canada's errorriddled "voter information cards" should never be allowed to be used as ID"
- Many users shared photos and comments on lawn signs, including high-engagement posts about satirical signs, and concern about signs defaced with swastikas
- Many posted about campus service points; most posts simply announced their availability and encouraged voters to use them

Éléments sous observation / On the radar

- Aside from long line-ups at Trent University, users do not report problems with on-campus voting: A get-out-the-vote organization called "Future Majority" (futuremajority.ca) tweeted about "long wait times" at an on-campus polling location at Trent University, with "only 4 people processed at a time." The organization tagged EC's Twitter account to ask if there were "any way to send more poll staff in?" The tweet received two engagements. This was the only social media post to report long lines on October 5.
- Concerns about accessibility in GE43: One user who describes themselves as being unable to leave their home, criticized EC for not having accessible voting options and hoped that EC restores the practice of sending personnel to the homes of voters with mobility issues; the user described the current voting options as "not fair" and as "infringing" on their right to vote. The post received 14 engagements on Facebook.
- **High-engagement tweet claimed Canada uses machine-voting:** The user (8.7K followers) urged others to "make a list of people [they] know" when voting and to "make sure the machine you vote on is recording what you press," adding that "we cannot trust Elections Canada." In another tweet the user emphasized the need for scrutineers and stated that "EC has hired lots of immigrants" to work at the polls. The user's tweets received 163 engagements, with some users replying that, in fact, Canada uses paper ballots.
- Twitter user expressed dismay at the use of pencils in GE43: The user stated "are we going to be voting using a *pencil* again?" adding "you've got to be kidding me!" and suggested that the use of pencils may lead to election fraud. In another tweet the user tagged @SharpieCanada and urged others to "get [theirs] before [they] vote" and in a third tweet the user announced that they "REFUSE" to vote using a pencil in GE43. The tweets received 44 engagements, with one user suggesting EC start using "black pen[s]" to avoid the election being "rigged."
- Organization that "upholds traditional Canadian values" criticized use of a mosque as a polling location: Canada Matters (18K likes) posted a photo of a VIC with a mosque listed as the polling location and added that the LPC has the "Muslim voting block locked up." The post claimed that EC's "pro-Liberal bias" made it "no surprise" the agency chose a mosque as a polling location. The Facebook post received 235 engagements, with some users accusing EC of "rigging" GE43 in favour of the LPC.
- Concerns over marking special ballots for Maxime Bernier running in Beauce, QC: Two lowengagement tweets raised concerns about how EC would distinguish between special ballots cast



for PPC candidate Maxime Bernier and Rhinoceros Party candidate Maxime Bernier. One user asked whether the candidate's party needs to be written on the ballot, to which another responded by claiming that an EC representative had told them "not [to] write [the] party."

- Rhinoceros Party claimed to have set record for "most refused candidates" in an election: A press release posted on the party's website noted that their efforts to have the "Qu'Appelle 10" candidates added to the ballot in Regina-Qu'Appelle had fallen short, but that the party was responsible for setting a new record for "the most candidates ever prohibited from standing for election." The press release was also shared on Reddit where it received seven engagements.
- Francophone users reacted to La Presse article about EC workers greeting voters with "bonjour-hello": The article noted that EC is not the sole federal agency that applies this policy. Some Facebook users welcomed the directive as beneficial to francophone communities outside Quebec, while others asked whether it was being applied throughout Canada. A few users also expressed concern about being welcomed with English in Quebec, with one Facebook user claiming that French speakers will be negatively affected by this policy. The article garnered 541 engagements.
- Calls to report rumours about LPC leader Justin Trudeau to EC: Many Twitter users reacted to a *Post Millennial* article about the end of the LPC leader's tenure as a teacher at West Point Grey Academy, with one high-engagement tweet (628 engagements) claiming that LPC leader Trudeau had improper relations with an underage student during his tenure. Other users denounced the *Post Millennial's* speculation and the allegation made in the high-engagement tweet as "lies," with a handful of users claiming to have "reported [the lies] to EC"; one user claiming to have reported the "lie" to EC received 132 engagements.

Fait saillants sur les médias sociaux / Social media highlights

Recent *CTV Atlantic News* and *Global News* coverage of non-citizens on the NROE, some of whom report receiving VICs, sparked reactions across social media platforms. Many users ridiculed EC's "absurd" "honor system" and "expectation" that non-citizens will come forward and ask to be taken off from the NROE. On Facebook, users who engaged with a *Global News* video about two non-citizens in Edmonton receiving VICs noted that they had never been asked to prove citizenship at the polls and some wondered how many "illegals" would vote due to vouching. One user also claimed that EC does not train polling staff properly when it comes to ID requirements at the polls. Users who engaged with *CTV Atlantic News*' coverage on the topic criticized EC for sending out VICs to non-citizens, and a handful of users noted issues with spelling on their VICs; one user suggested EC "cancel" all VICs sent out to ensure only error-free VICs are used in GE43. One user also claimed that they had not received their VIC due to the fact they "support Andrew Scheer," adding that they were sure they would have received their VIC had they been an LPC supporter.

On Twitter, users speculated about whether non-citizens ending up on the NROE is a "liberal fix" with one user stating that the LPC is "doing everything in [its] power to let dogs, cats, [and] illegals" vote and another advocating for "tough" scrutineers at the polls. Some users found it concerning or "disgust[ing]" that there is no requirement to prove citizenship at the polls and speculated that "steady streams of foreigners" would vote for the LPC. A handful of users called for EC to be "investigated" for "influencing" GE43, with one user inviting others to join in on a "class action lawsuit" against EC for not "maintain[ing] an ethical electoral process." One user also questioned why EC offers the option of having an "interpreter" since, according to the user. being a citizen requires fluency in at least one of the two official languages.

Reddit users speculated over how non-citizens could end up on the NROE, with one of the most liked comments offering a simple explanation – that non-citizens, or those doing their taxes, marked the citizenship box without paying attention. Another user, noting that 103,000 made up "only 0.4%" of the electorate in GE42, suggested that the issue was being blown out of proportion.

Fait saillants sur les médias sociaux / Social media highlights

Many users reacted to media coverage of convicted murderer Luka Rocco Magnotta receiving a VIC at the address where he committed the murder for which he is incarcerated. Users who engaged with the article ridiculed how "imprecise" and "error-riddled" the NROE is, though one user noted that the errors in the NROE were due to "voter apathy more than anything else" since voters were not updating their information as frequently as they should. A handful of users also criticized the right of incarcerated people to vote.

Social media users continued noting that they had received VICs, with a handful of users noting problems. One claimed that they had received a VIC addressed to their deadname, and that when they went to an EC office to address the issue, EC had allowed them to "vote early for their troubles." Two users noted that their names were either wrong or spelled wrong on their VICs, and one user claimed that their polling place was too far away; the user asked if EC would provide a "discount on gas" for those inconvenienced by the distance.

Fait saillants sur les médias sociaux / Social media highlights

There were a number of posts about election signs over the weekend, with two high-engagement posts about satirical lawn signs, and two reports of signs defaced with swastikas. Blogger Mike Morrison tweeted three photos of satirical lawn signs that state "Don't Elect Scheer" followed by the words "bullsh*t," "nonsense" or "stupidity." The bottom right-hand corners of the signs include the text "authorized by a sophisticated operation." A sign featuring LPC leader Justin Trudeau with a cigarette or joint in his mouth and the text "stupid people vote Liberal" appeared in the GTA.

Election signs for both LPC candidate Marc Garneau (Notre-Dame-de-Grâce—Westmount) and CPC candidate Mariam Ishak (Pierrefonds—Dollard) were defaced with swastikas, leading users to say such activity was "disgusting" and "revolting." On his official Facebook page, CPC candidate Scott Davidson commented on "vandalized" and "stolen" lawn signs in his riding of York—Simcoe and added that his campaign will "not be intimidated" by such actions.





