


Rapport de repérage des médias sociaux : midi 8 octobre à midi 9 octobre, 2019 Social Media Monitoring Report: noon October 8 to noon October 9, 2019


Observations principales / Key observations

- A Facebook post about a non-citizen in Beiseker, AB, who received a VIC was shared 22K times;
 various news articles covering the topic were shared 10K times
 - One user adapted the text from the Facebook post and included a photo of their own VIC,
 claiming they were also a non-citizen who had received a VIC
 - Others posted the text and image from the Facebook post without stating that the VIC in question was, in fact, not theirs
- Multiple high-engagement tweets about non-citizens on the NROE, including one by Senator Denise Batters suggesting "error-riddled" VICs are much more common than EC admits
- Users reported long lines at campus voting sites at Western, Ryerson, Concordia and Trent universities

Volume — Includes mentions of CEO, CEA, and variants, in English and French, on Twitter, Reddit, Tumblr, blogs, forums, YouTube comments






Sujets principaux / Key topics¹

- Concerns about voter ID requirements, vouching and non-citizens on the NROE
- Concerns about vandalized and stolen lawn signs

Éléments sous observation / On the radar

- On final day of on-campus voting, users report long lines at Ryerson, University of Western Ontario, Concordia, Trent and University of Toronto (Mississauga): A number of student GOTV campaigns tweeted about long line-ups at universities in Ontario and Quebec. "Future Majority" tweeted photos of line-ups at Trent University (where students are said to have "lined up all morning") and at the University of Toronto (Mississauga). At the University of Western Ontario, a user tweeted a photo of 34 people lining up for an on-campus poll, noting that students were waiting "40+ minutes." At Ryerson University, a user took a photo of a line-up of 28 people that "bends around" and "goes all the way up the stairs." A user at Concordia University took a photo of a line-up with at least 31 people. In addition, Calgary Mayor Naheed Nenshi tweeted to his 387.7K followers that "on-campus voting is now open at MRU, BVC and UCalgary." SMMU will be on the look-out for high turnout in Western Canada through the end of October 9.
- A Reddit user claimed that a poll worker challenged their use of a "BC Photo Services Card" as a form of ID at a campus poll: In a thread discussing everyday use of a "BC Identity Card," one user mentioned that they had used their "BC Photo Services Card" at a campus poll in Vancouver where two poll workers requested "a second piece of ID." However, after "check[ing] their info," the workers accepted the user's ID and the user was able to cast a ballot. In another comment, the user noted that EC "is desperate for workers" which might explain why "the standards aren't very high."
- A Reddit user claimed that "people are being removed from the [voter] registration" list: The user urged others to check their "voter identification card," adding that they had been "removed from the registry this year," and that EC "fixed" the issue but only after they contacted the agency three times. The user speculated that others may be unaware they have been removed from the list, to which some responded that it was not that concerning considering it is "almost ridiculously easy" to meet EC's ID requirements and register on the spot at the polls. The post received 26 engagements.
- A user who claimed he received a "2nd voting card inside two weeks" asked "Whats up Elections Canada???": He evidently did not notice that one of the VICs was a "Replacement Card." The tweet received seven engagements.
- A Twitter user claimed there were LPC signs "5 feet" from a campus polling station: The user said they saw "someone holding liberal signs" as they entered a campus polling station at

"upper Place Riel" at the University of Saskatchewan, adding that the practice was "illegal." The tweet received seven engagements.

- A Twitter user suggested the CEO was not proactive enough in stopping foreign interference in the form of U.S. Republican Party "operatives": Following a string of tweets about a former Republican strategist working on the CPC campaign, a user with 1.5K followers suggested the CEO should do more to impede U.S. party influence during GE43, saying "the CEO is quite ok with foreign right-wing white nat. undercover American stooges acting as '3rd party' agents for Cdn party candidate?" The tweet received one engagement.
- Friends of Science continued to thank EC for its "warning" about climate change talk and promoted a new billboard: The organization that presents "alternative causes" to man-made climate change continues to tweet its thanks to EC. In a recent tweet, the organization shared an undated image of a billboard that states, "Politicians can't \$top climate change.

 FriendsofScience.org." The tweet received 33 engagements.

Users continued sharing a Facebook post by a non-citizen in Beiseker, AB, who received a VIC (20K engagements), with some users adapting large parts of the post's text and incorporating it into their own posts on various social media platforms. One user name on both Twitter and Instagram shared a slightly altered version of the post's text, with a photo of their own VIC, claiming that they, too, were a non-citizen who had received a VIC. A handful of users copied and pasted the high-engagement Facebook post's text, including the original photo, and shared it on their Twitter feeds without stating that they, in fact, were not the person listed on the VIC. In a reply to such a tweet, one user noted that there were a "crap ton of accounts" that were "all posting under different names claiming this to be 'theirs'," and questioned the authenticity of the tweet. One Facebook user commenting on a CBC News' article on the topic made a similar observation.

Senator Denise Batters also chimed in on the topic by sharing a *CBC News* article about the Beiseker man receiving a VIC, and suggesting that "mistakes" with EC's "error-riddled" VICs are not as "rare" as the agency has led on. In a series of tweets, freelance journalist Amy MacPherson, who in September alleged that 2001 photos of the LPC leader in "brownface" makeup were foreign interference, suggested that non-citizens on the NROE could be the result of "election fraud" stemming from Alberta's election, which may have "tainted" or "fundamentally corrupted" EC's voter database. MacPherson concluded that non-citizens receiving VICs could be an indication of "foreign interference."

Other users who engaged with the topic continued sharing articles and high-engagement posts about non-citizens on the NROE, with many users voicing their disappointment over EC not requiring proof of citizenship at the polls, accepting vouching, and not having "done its job" of addressing issues with the NROE prior to the election. One user stated that EC would "not find [its] way out of a water soaked paper bag," while another suggested that "all employees of EC should be charged with treason." Some users noted personal experiences or anecdotes about receiving misspelled VICs or VICs addressed to persons who do not reside at their address. Many users also speculated that non-citizens on the NROE are further proof of "EC working for Trudeau," and of GE43 being "rigged." One user suggested that the presence of non-citizens on the NROE was a tactic similar to that used in Quebec's 1995 referendum in which citizenship applications for qualified immigrants were fast-tracked in time for them to vote in the referendum.

This same concern was echoed in Facebook posts on the CBC story about new Canadians from Syria voting for the first time. The story noted that in Syria, elections are "a theatre act." A user replying to the story said "by the reports that non Canadians are receiving voter cards, it's a theatre act here too. We can only hope that any that receive cards vote to keep this country free" (51 engagements). Another opined: "With voter cards going to 100s of thousands of non citizens the election is a bit of a joke here are well."

User interest in damaged election signs continues, with a flurry of news articles about vandalized signs in Kitchener, Regina, Fredericton and Kelowna. Although most users are not calling on EC to intervene to stop further defacement of election signs, many said the practice was "wrong" or noted that "everyone has a right to their opinion." Someone spray painted the word "FASCIST?" on a PPC candidate's sign in Kelowna–Lake County, similar to a Central Okanagan–Similkameen–Nicola PPC candidate whose sign was tagged "FASCIST?" last weekend. In Quebec, CPC candidate Joël Godin's (Portneuf–Jacques-Cartier) sign was defaced with the words "Ø pipeline." Multiple signs belonging to different parties were vandalized in Fredericton.

Users continued engaging with anti-LPC lawn signs, seemingly distributed through the Veterans for the Conservative Party of Canada's Facebook page, with multiple high-engagement tweets featuring photos of veterans next to the signs. In Toronto–Danforth, *CBC News* reporter Kaleigh Rogers posted a photo of a poster stating that "2015 was the last election under the first-past-the-post system," likely criticizing LPC for its 2015 campaign promise.


