


Observations principales / Key observations

- Users reacted to former U.S. President Barack Obama endorsing LPC leader Justin Trudeau; some
 questioned the legality of the endorsement, while others expressed disbelief at EC's position that
 the endorsement does not violate the Canada Elections Act
- For the third day, *True North News* published articles and videos about non-citizens on the NROE, earning more than 7K engagements; many users expressed disappointment in EC not requiring proof of citizenship at the polls, with one user claiming that they voted with their VIC and a library card while wearing a scarf and sunglasses to show how "ridiculous" EC's ID requirements are
- Users in Vancouver reacted to a "misleading" PPC flyer containing EC's contact information, with one user stating that they "absolutely thought" the flyer to be from EC

Éléments sous observation / On the radar

- User accused DRO of "opening" their ballot "3 times": The user (1.5K followers) stated that when they voted, the "DRO at [their] poll desk took and opened" their "folded-in-three ballot" and looked at it "3 times." The user stated the opened ballot was also visible to the clerk and added that they "called the Riding['s] top officer" to report the DRO and hoped that the DRO was fired. The tweet received five engagements.
- Two Manitoba voters inquired about EC's efforts to administer GE43 in the province following harsh weather: One user (77 followers) replied to EC's Twitter account and asked whether the agency had a "contingency plan in place for those who might not be back in their communities" by election day, receiving one engagement. Another user (142 followers) stated that despite being "more engaged in this election than any other," they did not even "realize" that advance polls were open, adding that advance polling in Winnipeg was "perhaps [not] announced as predominantly" due to the winter storm. The user concluded by stating that they were going to vote on election day, receiving no engagement.
- User claiming to be a poll worker offered candy for those who "wear red" when voting: The user stated that they are working on election day, urging others to "come vote to see" her and adding that those who wear red would receive candy from her. In another tweet, the user stated "don't fire me Elections Canada it's a joke." The user's two tweets received a combined seven engagements.
- Four users shared inaccurate information about the date of election day: Three Twitter users, in separate posts, erroneously stated that election day is October 22. One user with 58 followers claimed that the date has been changed for "Liberal voters," while another user with 1.1K followers declared the date as "Vote For Andrew Scheer Day." A fourth user claimed that October 17 was election day. All four posts garnered no engagement.
- Users had mixed reactions to EC's collaboration with Snapchat: One user (700 followers) who commented on EC partnering with Snapchat accused both EC and the social media outlet of "foreign interference," while a second user (46 followers) questioned the legality of the collaboration. A third user (6 followers) noted that the promotional graphic features a Snapchat figure (Bitmoji) wearing a "nice red shirt" and added "just saying!! no influence here." A fourth user (1.9K followers)



stated that "the Leftists are pulling out all the stops" and speculated that the collaboration was due to LPC's "internal polling numbers" being "in the tank."

- User claimed Lyft will offer discounted rides on election day: The user (165 followers) tweeted out that ride-hailing company Lyft is "sending out promos for people to get out and #vote." The user shared a screengrab of the ad which reads, "Your Election Day ride: Election day is almost here! And to help make sure your voice is heard, take 50% off your ride to the polls on Oct. 21." The tweet did not receive any engagement.
- User concerned that poll worker allowed them to keep their VIC after voting without stamping it (to show it has been used): A user with 679 followers said they voted on October 11, and was "surprised" that a poll worker only asked to see their VIC and driver's license. The user added that the poll worker told them they could "keep the card" and returned it without having cancelled it as one would do with a used postage stamp. The user asked her followers if she could use the VIC to vote again, and why EC doesn't "screen" voters by birth certificate or citizenship certificate. The tweet did not receive any engagement.
- Facebook user called on EC to "break down barriers" for deaf poll worker applicants: The user posted a video explaining her application to become a poll worker for GE43, but was notified too late by the RO office whether an American Sign Language (ASL) interpreter was available for mandatory training. The user said the RO office was not responsive in confirming whether they had arranged an ASL interpreter from the Canadian Hearing Society, and was only notified that one would be available after she withdrew her application. The user said she found the situation "unprofessional" and that accessibility "should be important to [EC]." The user said she reached out to EC, her MP and the CHS for comment on the matter, but "only heard back from her [MP]. The video was viewed 3.5K times and received 236 engagements.
- Twitter user asked why EC "misgenders and outs their employees": The user posed the question to their 32 followers and received one engagement.

After former U.S. President Barack Obama tweeted an endorsement of LPC leader Justin Trudeau, a number of Canadian journalists weighed in. *CTV News* journalist Don Martin called the tweet "highly unusual," and noted that he "can't recall a precedent for this." *Washington Post* commentator JJ McCullough said he did not want to be "overly reactionary" and "scream foreign influence," but suggested it is reasonable to ask if there was "collusion" from the LPC leader in seeking Obama's endorsement. Independent oil industry researcher Vivian Krause noted Obama's tweet and stated that it showed how "absolutely laughable" EC's third party advertising regulations are since Obama's endorsement does not fall under EC's third party provisions. In an article shared over 8K times, commentator Spencer Fernando claimed that Canada was on the receiving end of "foreign interference".

Other social media users expressed disbelief at EC's position that President Obama's tweet does not constitute foreign interference, and cited climate activist Greta Thunberg as another foreigner who seems to be interfering in this election. Some speculated that the LPC had paid Obama for his endorsement, or that LPC leader Trudeau would "donate to the Obama foundation" after GE43. Many users were unimpressed that foreign leaders can endorse candidates in Canada without being subject to any regulations, with some speculating that EC's position on the matter would be radically different had U.S. President Donald Trump endorsed CPC leader Andrew Scheer.



For the third consecutive day, *True North News* continued coverage of potential non-citizens on the NROE. In a video shared on Facebook and YouTube, TNC fellow Andrew Lawton discussed how an "unknown number of non-citizens are receiving voters cards," to which users responded by calling for "immediate deportation" of non-citizens who vote. One user was adamant that only "drivers license and citizenship card[s]" should be accepted at polling stations, while another suggested the criteria for voting should be "1. Canadian citizenship ONLY. 2. Born in Canada. 3. Resident in Canada." A number of users suggested that a grand conspiracy involving the LPC and Elections Canada was taking place, with one user claiming that "the globalists have already counted the thousands of illegal votes." Another user went further and stated that EC "are in bed with Liberal, NDP, and Green Party."

Facebook users on niche political page "Ontario Campaign Canada" discussed a recent London Free Press article about a resident of London, ON, receiving a VIC for their deceased non-citizen spouse. Many users who commented on the article questioned why the NROE was not up-to-date, especially after "how much death tax people pay." Another user said that EC was "stacking the deck" for the "Fourth Reich Liberals."

On Facebook, one user posted a photo of themselves wearing sunglasses and a scarf covering their face, adding that they were en route to a polling station to use their VIC and a library card as ID while voting. The user also stated that if their attempt to vote with such ID and their face covered was successful, it would be "totally ridiculous!" After having visited a polling station, the user commented that it was "ridiculous" that "it work[ed]" and urged others to do the same. One user who replied said "someone should be fired for this farce," while others pondered the religious ramifications of hiding one's identity at the polls, claiming that it is "definitely not something Jesus would have done."



Users in Vancouver reported that they had received GE43-related flyers with vague-to-no reference that they were from PPC candidate Azmairnin Jadavj's campaign (Vancouver North). Some users noted that the flyers featured EC's phone number, with one user stating that they "absolutely thought" the flyer was an official EC communication. The flyer included an overview of the PPC, CPC, LPC and GPC's platforms, with a "distinctly pro-PPC slant," and made no mention of the NDP or the NDP's platform. One user called the flyer "ballsy," while others stated that they were not aware that it was a PPC ad until seeing tweets by *Vancouver News 1130* journalists, which prompted some to note that "pretending to be [EC] is probably illegal" and to "report" further such letters to EC. One user reported having received such a flyer in Edmonton, AB.

Some users continued to express concern about using pencils to mark ballots, though interest in this topic continued to decrease. It appears that some users are still basing their concerns about writing instruments on the viral r/metaCanada post about an unfounded claim of selective ballot tampering at an advance poll in Toronto. Some users mentioned issues like "pencil smudging" and poll workers "in a back room erasing furiously and changing the ballots!" Users who are engaging with his topic continue to urge others to bring a pen or a sharpie to the polls.

Users continued to post photos of damaged signs, including photos of uprooted signs in Victoria, Mississauga, Kitchener, Toronto, and New Brunswick. PPC candidate Jing Lan Yang (Caribou—Prince George) took photos of vandalized signs in her riding, and stated that she planned to "file a police report." A Twitter user in Kitchener Centre also took notice of vandalism, taking a photo of a defaced sign for GPC candidate Mike Morrice. In a news piece for *The Pointer*, LPC candidate Sonia Sidhu (Brampton South) claimed that "hundreds" of her signs have been vandalized, while CPC candidate Harold Albrecht (Kitchener—Conestoga) said someone was stealing his lawn signs from private property, and urged anyone who witnesses lawn sign theft to call the Waterloo Region police. In Edmonton, a man who has decided to place all six federal party signs on his lawn said he frequently loses his signs to thieves. One user posted a photo featuring NDP candidate Salman Tariq's (Mississauga—Erin Mills) on the ground, with LPC candidate Iqra Khalid's (Mississauga—Erin Mills) signs in tact in the background, while another user criticized CPC candidate Stephen Woodworth's (Kitchener Centre) signs for featuring the word "re-elect."

Users reacted to LPC candidate Catherine McKenna's (Ottawa Centre) all-black signs stating "vote for gun control," and wondered if it was indeed an actual sign. CBC News London featured a story about an "old hippy" who made his own signs criticizing all "political reps" for "coming with strings attached."


