


Rapport de repérage des médias sociaux : midi 15 septembre à midi 16 septembre, 2019 Social Media Monitoring Report: noon September 15 to noon September 16, 2019

Observations principales / Key observations

- Anti-Racist Canada publishes names and cities of two CNP signees as a "teaser"; says it will release the rest of the 250 names soon, but will not disclose signees' street addresses
- Recent podcast on election security featuring the CEO shared six times on Twitter
- Social media users show continued interest in expat voting
- Decline in volume of posts calling on EC to "review" allegedly false claims by or about party leaders

Éléments sous observation / On the radar


- Attention Control podcast featuring the CEO shared six times: A recent podcast by journalist
 Kevin Newman (35K followers), in which the CEO is interviewed, was shared six times on
 Twitter. Newman's two tweets promoting the podcast received a total of 13 engagements.
- Twitter user with 30K followers claims LPC Leader Justin Trudeau has "corrupted" EC: In one high-engagement tweet, a user claimed Trudeau had "corrupted" nine different government institutions and agencies, not including EC. In a later tweet, the user retweeted their original

tweet adding "I need to add: 10. Elections Canada." In total, the two tweets received 631 engagements.

- Twitter user claims fraud in GE42: A Twitter user with 2.5K followers tweeted that former Prime Minister Stephen Harper was "installed by fraudulent voting machines" and called on EC to use "paper ballots with a tear off receipt of actual choice." The tweet received six engagements.
- Timing of GE43 and Jewish holidays: In a reply to a tweet by Senator Linda Frum alleging anti-Semitism in LPC ranks, a Twitter user with 452 followers stated, "This is why Election Canada didn't want to change the election date," adding that GE43 is scheduled to take place on October 21 since "JT and liberal goons" are hoping for a low Jewish turn out at the polls. The tweet received one engagement.
- Twitter users confused about lack of candidates' lists on EC's website: A number of low engagement tweets wondered why EC did not have a list of confirmed candidates on its website. A Twitter user with 325 followers claiming to be "a former EC manager," replied to a number of tweets on this topic. In one tweet the user stated that candidates' names will be available on EC's website once the "already-sanctioned candidate files their paperwork with the local Returning Officer." This tweet received 3 engagements.
- Twitter user states that EC staffing up for GE43 "spells trouble": A user with 8.7K followers tweeted that EC is looking to fill 235,000 paid positions in time for GE43 and stated that this "spells trouble." The tweet garnered six engagements.

On September 15, The Anti-Racist Canada Collective (ARC) published an article on its <u>website</u> outlining its plan to publicize the names of 250 CNP members who endorsed the party's establishment. The article notes in screengrabs from various CNP Twitter accounts that CNP members are "terrified of having their membership revealed." The article argues that documents signed by people supporting the creation of the CNP are "the property of all Canadians" and are thus "subject to public scrutiny," like all other parties' registration documentation. The article includes scans of EC-branded documents signed by two members of the CNP, showing their full names and cities of residence. ARC has opted not to publish the street addresses of CNP signees and is instead choosing to only publish CNP signees' names and cities/towns. ARC is planning to publish a full list of names and cities/towns of CNP signees in the "next few days."

Soon after the ARC tweeted out its newly published article, the CNP Twitter account responded that it is "worthwhile to note" that just because an individual endorsed the creation of CNP does not mean they endorse the party's views. Although ARC was not tagged in the tweet, SMMU finds it likely that the CNP's tweet was an indirect response to ARC's article.

The Canadian Anti-Hate Network (CAN) – who had previously stated that they would reveal the names of CNP members – showed their support for the ARC by retweeting the September 15 blog post. ARC is believed to be working with CAN on releasing the full list of 250 CNP signees.

Fait saillants sur les médias sociaux / Social media highlights

The volume of posts on this topic declined. Twitter users had mixed reactions to the LPC tweeting out a <u>form</u> that gives Canadians living abroad "all the information" they need to request a special ballot "to vote for Justin Trudeau." Many expat Canadians chimed in on the topic, and expressed excitement that they can vote in GE43. Some also shared EC's website on voter registration for Canadians residing abroad. A handful of users thought it inappropriate that people who do not reside in Canada are allowed to cast a ballot. Some users were of the opinion that expatriates are "citizens of convenience" who should not be allowed to vote. One Twitter user suggested that restoring expat Canadians' right to vote "weakened voting laws," while another user wondered how much the LPC had paid EC to "enact" the *Canada Elections Act* to allow expats to vote.

Fait saillants sur les médias sociaux / Social media highlights

The volume of social media posts on this topic declined. Some Twitter users continued to comment on a high-engagement tweet on September 15 that outlines "allegations" about "the Liberal candidate in Papineau." Users tweeted copies of the original tweet to which other users stated that they would report "each and every one" to EC. Some Twitter users also reacted to a campaign video by CPC candidate Candice Bergen, claiming that she was "lying" and stating that they would report the video to EC. Users had similar reactions to a video featuring CPC leader Andrew Scheer. One user shared a link to the CCE's complaint form, but the tweet received no engagement.

A Twitter user with 1.1K followers noted that the *Canada Elections Act* does not prohibit "any and all false statements" and urged users to check the Act prior to "inundating" EC with reports. This tweet received four engagements.


A handful of Twitter users commented on two separate topics related to third party advertising on climate change-related issues. Three Twitter users commented on climate activist Greta Thunberg's planned visit to Canada, alleging that it was "illegal campaigning" and "foreign interference." Another Twitter user took issue with a pro-carbon tax group that is allegedly engaging in political advertising but "refusing" to register with EC.

Are we seeing the same key topics in questions posed to Elections Canada?

- On Twitter we've received many comments around allegations of false claims by candidates (99/197), including campaign speeches, CPC brochure. We had traffic and questions around voting and registration, including questions around voting by mail, and messages related to campaigning, signage, and some questions on employment.
- Top topics on Facebook pertain to employment, voting, and registration.
