### Social Media Monitoring Report: noon September 24 to noon September 25, 2019

#### Observations principales / Key observations

- Some social media users allege American Youtube talk show host Dave Rubin’s offer to pay for his security detail at a PPC event violates the CEA
- Users respond to MP Adam Vaughan’s complaint to CCE that “gun lobbyists are skirting” election laws
- Users continue to discuss defacement of lawn signs; some claim that “all CPC signs” in Toronto–Centre have been vandalized

#### Éléments sous observation / On the radar

- **Twitter user plans to report the Canadian Anti-Hate Network to EC for “election tampering”:** In a series of tweets, the user (1.4K followers) stated that they would report the “hateful” “fascist” group to EC and the RCMP for “election tampering,” “intimidation of PPC members,” and “doxing”; in a later tweet the user claimed that they had called Vancouver police who “made it very clear that this was against the law.” The tweets received 50 engagements in total.
- **Facebook user warned fellow Hamiltonians of sexual offender working for EC:** A Facebook user who appears to be in the Hamilton area posted a warning about the convicted sexual offender working as a revising agent; it seems she made the post public sometime on September 24, a day before the *Hamilton Spectator* story broke. As of September 25, the post had received 37 engagements; this has not increased since. One user commenting on the post expressed shock that EC would employ a sexual offender so well known to the community.

- **Twitter user claimed “machines” are “infiltrating” Canada’s elections:** Commenting on an October 2018 *Star Tribune* article about election security in the U.S., the user (4.2K followers) claimed that machines are “infiltrating” Canada’s “hand marked, handcounted ballot elections” and added that three voting machine companies accused of “skimp[ing] on security” in U.S. elections are “all cozy in Toronto.” The tweet received 10 engagements.
- **Twitter user expressed distrust in EC’s collaboration with Facebook on voter registration:** The user (3.5K followers) claimed that EC’s collaboration with Facebook on voter registration was “not real” and deemed it a “deliberate attempt to undermine” Canadian democracy; the user added that the campaign “smacks of the Conservative robo-call incident” and suggested that it might be “voter suppression.” The user’s three tweets on the topic received a total of 10 engagements.
- **Twitter users discuss whether EC guidelines on third parties will put a chill on climate change-related events at universities:** A user with 1.4K followers tweeted a general question to “Canadian academics,” asking if EC’s guidelines would lead universities to hold off on public events about climate change. A York University professor said “no, or at least not reasonably,” and that EC’s rules on advertising during the writ period are “quite clear.” However, he also expressed shock that some groups couldn’t “discern between paid ads and everything else.” The exchange received two engagements.

<p><b>Fait saillants sur les médias sociaux / Social media highlights</b></p> <p>Following reports that LPC Spadina–Fort York candidate Adam Vaughan had filed a complaint with the CCE that the Canadian Shooting Sports Association (CSSA) had not yet registered as a third party for GE43, social media users both opposed and supportive of gun control, made their voices heard. While most directed their comments at Vaughan and the LPC, a number of users suggested they were “disappointed” that CSSA had not registered as a third party at “such a serious time in history for gun owners” and noted that the Canadian Coalition for Firearm Rights (CCFR) had already registered.</p>

A few social media users alleged the PPC leader and an organizer would be doing something illegal if they accepted an offer from Dave Rubin, an American Youtube talk show host .

*The Hamilton Spectator* published an opinion column on PPC Leader Maxime Bernier's plans to have an event with Rubin in Hamilton. Guest columnist Evan Balgord, head of the Canadian Anti-Hate Network, decried the event and the college that accepted to host it. Soon after, Rubin tweeted that "The school is now demanding 10 times the original security costs and could demand more before showtime" and offered to pay for the security costs out of his own pocket. Some Twitter users said the PPC could not accept such a donation from a non-Canadian, accusing a PPC organizer and PPC Leader Maxime Bernier of "soliciting foreign donations." Two users noted that "political contributions from foreigners are illegal in Canada" and stated that they would be reporting any such solicitations to EC.

A handful of users wondered whether the UCP was aware that its campaign was "violat[ing] Elections Canada laws."

### *Fait saillants sur les médias sociaux / Social media highlights*

A few social media users continued to express concerns about voting from abroad and the potential of non-citizens being on the NROE. Vivian Bercovici, columnist and former Canadian diplomat, stated that the special ballot system in use is “prehistoric” and “obsolete” and suggested that special ballots are susceptible to “tampering”; she called for a “better” system for Canadians voting from abroad and suggested using “embassies/consulates” as polling places. One Twitter user stated that the fact that voting by special ballot is allowed before the candidate lists are finalized is “unfair” and a “type of electoral misconduct.”

Some users also voiced concerns about non-citizens voting in GE43, with one user questioning what efforts EC is making to “safeguard the integrity of the elections” and to verify that those voting are Canadian citizens. In a high-engagement LinkedIn post, one user questioned whether current voter ID requirements are enough to “ensure the integrity” of the election; one user replied that “everybody” had documents which serve as proof of Canadian citizenship, citing birth certificates and “the letter” all those who have “legally acquired citizenship” have in their possession.

Discussion about lawn signs continued on social media. One user reacted to a CPC lawn sign being "ripped up and replaced" with an LPC candidate's sign, and urged the LPC candidate in question to "stay classy." On Reddit and Facebook, some users noted that every CPC sign in downtown Toronto had been spray painted with the word "dont" [next to the word "elect"], or otherwise vandalized. One Facebook user in London, Ontario noted that PPC signs had been vandalized; the user added "it is ugly out there," referring to the alleged assault of a GPC canvasser in the city.

Amy MacPherson, the freelance journalist behind a September 23 *Free the Press* article claiming that *Time* magazine's discovery and coverage of the 2001 photos showing LPC Leader Justin Trudeau in "brownface" makeup is "foreign interference," discussed her story on the podcast *The View Up Here*. After her appearance on the podcast, MacPherson posted a long Twitter thread on the topic, in which she called on EC to also investigate *Global News*, *The Sun*, and *Niagara Falls Review* for "collusion" with the CPC. At the end of the thread, MacPherson shared EC's "Contact us" web page and urged others to file a complaint with EC.

One user who engaged with this topic claimed that GE43 is being "targeted" with foreign interference "on the behalf of CPC," while two others stated that they wanted to make sure EC is made aware of the "election tampering." Some users also shared the CCE's complaint form and stated that they had already filed a complaint with "Elections Canada."

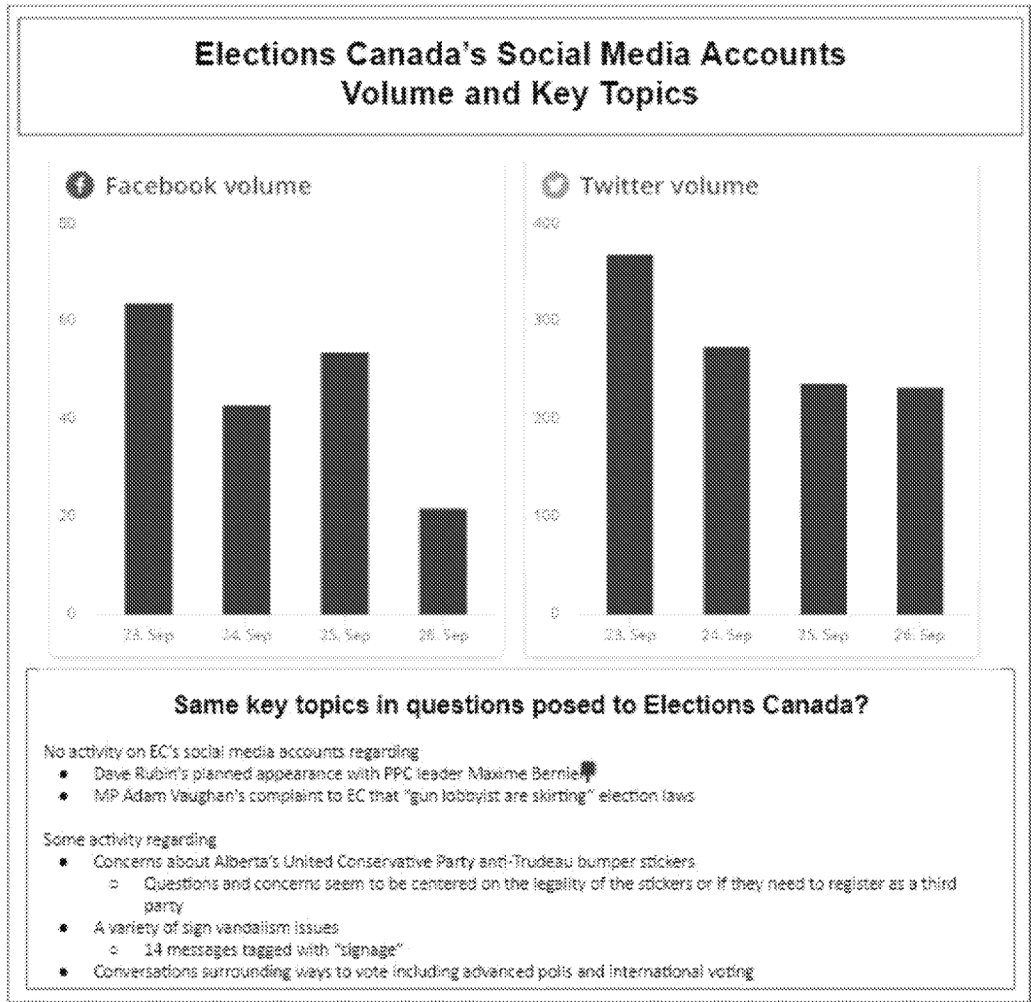
