The reason is simple. Once this Bill has passed all readings and becomes the law, every individual or organization connected to China may be considered to be a representative of the Chinese government and be required to file a special return.

So, what's the problem with filing a return? After a return is filed, any activities related to the mainland Chinese community and any normal events involving economic, cultural and technological exchanges between Canada and China may be suppressed. The freedom of expression of ethnic Chinese could also be suppressed. It is also very likely that [the Bill] would have profound negative impact on the Chinese community.

Based on this definition, any individual or organization engaging in the following will be deemed as being influenced by the Chinese government and will hence be designated as a foreign principal of China: Establishing hometown associations or organizing [related] events and receiving a congratulatory letter from home country government authorities for establishing an alumni association or organizing [related] events; it also includes any individual and organization attending Chinese National Day receptions or Lunar New Year celebrations organized by the Chinese Consulate, organizations inviting consular officers to attend an event, and individuals and organizations in contact with a Chinese official of any level; it even includes individuals who have worked for mainland Chinese organizations, including the government and state-owned enterprises, and organizations that received sponsorship from any private Chinese enterprises.

(Comprehensive report from the Global Times) The upcoming Canadian federal election is painting an interesting picture: As the governing party, the Liberal Party of Canada is trying its best to avoid talking about China in its campaign program and events. However, the Conservative Party of Canada, the opposition party, mentioned China 31 times in its campaign program, and it mentioned Beijing and the Communist Party of China numerous times. It has also developed policies that "practically mean breaking off diplomatic relations with China" and "will certainly lead to retaliation from China," according to an expert.

"The expert said that the Liberal Party remains silent toward Sino-Canadian relations, while the Conservative Party's approach might lead to retaliation from Beijing." According to an article in today's *The Hill Times*, Sino-Canadian relations have yet to become a focal point of this election, and relations have been damaged since Canada arrested MENG Wanzhou, senior executive of Huawei, following the order from the United States. Prime Minister Trudeau and the Liberal Party's campaign program mentioned China only once in the section of policies against "unacceptable behaviour" from authoritarian regimes. Russia and Iran were also mentioned in this section.

According to the article, Erin O'Toole, the leader of the Conservative Party, is in favour of adopting a "new method" to handle Sino-Canadian relations. The Conservative Party's campaign program listed numerous measures toward China, including no longer prioritizing trades with China, considering China's "persecution" toward Uyghurs as "genocide," taking measures against China's "foreign influence actions" in Canada, forbidding Huawei from participating in building Canada's 5G network, sanctioning China's "worst human rights violators," getting Canada out of the Asian Infrastructure Investment Bank, supporting "members of democratic parties" in Hong Kong, and developing "greater political cooperation" with Taiwan. Rick Roth, a member of the Conservative Party, expressed that Trudeau's government needs to assume responsibility for conducting diplomacy behind the scenes, while O'Toole does not have to. "He can be more brazen and direct when voicing his opinions."

"From reading the campaign program of the Conservative Party, you will see a party that practically wants to break off diplomatic relations with China," said Jocelyn Coulon, political

advisor to Stéphane Dion, former Canadian Minister of Foreign Affairs. According to him, the Conservative Party should put serious thought into Sino-Canadian relations, instead of preparing a sanction list that no other Western country would want to get involved with. The Conservative Party's policy on China "goes too far," as European nations clearly expressed to the United States [...]
